Duties & Responsibilities

Trainer

- Work with leadership to ensure efficient and consistent development for mold maintenance technicians
- Facilitate development of training materials
- Support development of standards for training
- Support activities related to new programs and relevant training (New technology, materials, etc)
- Willing to travel periodically where required (Receiving or supporting training)
- Responsible for duties outlined below for regular mold maintenance technician duties when training activities are not required

Mold Maintenance Technician

- Follow instructions and guidelines on proper cleaning and maintenance of molds
- Follow daily, weekly, preventative maintenance schedules to ensure high performance of molds within injection molding machines
- Repair molds to assist with reducing scrap rates and deformities within plastic parts.
- Assist MM Manager with inventory and supply tracking for Mold Maintenance Repair shop.
- Understands and practices safe working procedures. Use personal protective equipment with lockout/isolation procedures as required. Understands the specific environmental aspects and impact of maintenance duties and work toward reducing them.
- Makes sure that all mold maintenance work areas are properly maintained according to the specific 5S requirements.
- Manage and maintain daily job-related equipment concerns or issues.
- Troubleshoot and repair malfunctions of equipment or tooling.
- Participate in continuous process improvement efforts to reduce scrap, cycle times, improve efficiency and eliminate waste within the production environment.
- Must be available to work on weekends, off-duty hours, and shut-downs as needed to prepare for production.
- Other duties may be required ensuring that Diversity-Vuteq meets and exceeds our customer expectations and needs.
